ANTAM Road Map

- 1. Development of region wide agricultural standards that reflect the agricultural and technological needs of countries in Asia and the Pacific (2014-2016);
- 1. Establishment of a network of testing stations able to perform the standardized ANTAM Codes and produce consistent test reports (2017-2020);
- 2. Establishment of a mutual recognition agreement of for test results produced under the ANTAM umbrella (2021-2023).



ANTAM Work Plan 2018

- Development of the ANTAM official rules and regulations;
- Strengthened testing capabilities in the region;
- Revision of the current ANTAM Codes;
- Resource mobilization & partnership developed



Development of ANTAM Rules and Regulations

- ❖ ANTAM rules and regulations will tentatively include:
 - I. Official procedure to accredit testing stations;
 - II. Official regulations to appoint National Designated Authorities;
 - III. Official regulations regarding the appointment and the role of the Deliberative Committee;
 - IV. Official regulations regarding the role of the Technical Reference Unit;
 - V. Official lists technical requirements needed to apply for accreditation;
 - VI. Other documents as needed.



Strengthened Testing Capabilities in the Region

- ❖ CSAM will work on the **national** and **regional level** to assist member countries in the construction of modern **facilities** and develop adequate **human resources**.
- **❖** Up to 2 **Round Robin** tests:
- ANTAM 001
- ANTAM 002
- Analysis of results
- Applications to be submitted no later than February 28, 2018.



National Capacity Building

- ❖ CSAM will collaborate with member countries to develop tailored **national** strategies.
- ❖ To gather needed background information CSAM will circulate a template for application by the end of 2017.
- ❖ Focal points are expected to provide a full application form, by no later than February 28, 2018.
- **CSAM** will select up to two study tours in selected countries.



Regional Capacity Building

- ❖ At the **regional level** CSAM plans to organize at least one training of trainers to instruct testing engineers on the application of the ANTAM Codes and on the requirements for standardized testing equipment.
- ❖ To target member countries needs CSAM will circulate a **survey** and try to organize a training on the Code indicated by member countries.



Revision of ANTAM Codes

- ❖ In January 2018, CSAM will work in collaboration with focal points to review the composition of the Technical Working Groups (TWGs).
- ❖ CSAM plans to conduct negotiations on the ANTAM Code on Paddy Transplanters. CSAM plans to organize hold at least 7 rounds of technical negotiations and one in person meeting in the first half of 2018.
- **❖** CSAM plans to integrate member countries comments on 001-2017 and 002-2017.
- ❖ Subject to the final adoption by the 4th Annual Meeting of the proposed rule-based mechanism, from 2019 the ANTAM Codes will be updated once every two years unless at least 5 member countries request yearly updates.



Cross- Code Harmonization

CSAM will hold joint consultations among TWGs to harmonize testing procedures, structure and terminology across all ANTAM Codes, where applicable.



Resource Mobilization & Partnership Development

- ❖ CSAM plans to deepen the collaboration with the Institute of Agricultural Mechanization (IAM) of the Ministry of Agriculture, Forestry and Fisheries of Japan.
- ❖ CSAM will continue to explore the possibility of signing a triangular memorandum with the Chinese Certification and Accreditation Administration (CNCA) and the Italian Agency for Testing of Agricultural Machinery- European Network for Testing of Agricultural Machinery (ENAMA-ENTAM).



- ❖ CSAM will work closely with focal points and relevant divisions in ESCAP to propose a funding mechanism able to support the costs of certification.
- ❖ The 4th ANTAM TWGs Meeting will be held in the first half of 2018, while the 5th Annual Meeting of ANTAM will be held in the second half of 2018.
