# Overview

- Project title: International seminar on enhancing export competitiveness of Asian fruits
- Thematic focus: Managing globalization, poverty reduction

# **Situation Analysis**

#### Status and issues

- Horticultural production has emerged as a major economic activity in developing Asian countries.
- Demand for horticulture produce has been growing, but only about 15% of this trade involves developing countries.
- Asian Countries (ACs) has a lower exports of fruit as compared with South America 35%, Central America 33% of global exports.
- Postharvest loss of fresh produce is estimated 20-40% in Asian developing countries.

# **Situation Analysis**

## Opportunities

- ACs occupy 44% of the world's fruit acreage, and has wide range of temperate, sub-tropical and tropical fruits
- ACs meet challenges and opportunities by liberalized trade, globalization, accelerated urbanization, etc.
- Asian governments are interested in the export, which is crucial for their development
- Export of Asian fruits will provide many opportunities for ACs
  - Creating and increasing employments
  - Generating income of farmers
  - Driving economic growth in the rural area

# **Situation Analysis**

#### Constraints to export

- Inferior or inadequate post-harvest technology and food management system
  - Very low investment and financial support
  - Short shelf-life, high incidence of post-harvest disease
  - Lack of technology dissemination and adoption system
  - Poor infrastructure; small-scale farm, transportation, agro-facility
  - Still focus on production-oriented policy and R&D
  - ✓ Absence of policy and institutional support
- Market limitation in Asian countries
- High requirement of quality/safety standards
  - Low share of private sectors with post-harvest activities
