


- ❖ 2006, DAO 04: creation of the Philippine Accreditation Office (PAO)







PAB APAC MRA 2022

The Philippine Accreditation Bureau (PAB) is signatory to the Multilateral Recognition Arrangement (MLA) for Quality Management System (QMS) and **Environmental Management System (EMS) of Asia Pacific** Accreditation Cooperation (APAC) and International Accreditation Forum (IAF), and Mutual Recognition Arrangement (MRA) for testing, calibration, medical and inspection of APAC and International Laboratory **Accreditation Cooperation (ILAC).**

What is an MRA?

Mutual Recognition Arrangement (MRA) is an agreement signed by signatory accreditation bodies to recognize the equivalence of the accreditation schemes operated within the scope of their signatory status. It provides assurance that bodies from different economies operate to the same international standard.

APAC MRA

55 Full Members across 33 economies that are APAC MRA signatories.

The results issued by APAC MRA signatories' accredited conformity assessment bodies are accepted across the Asia Pacific region and internationally, thus contributing to the facilitation of trade and the free-trade goal of "tested/inspected/certified once, accepted everywhere."
